PRIVACY NOTICE FOR CO-APPLICANTS CONCERNING VELUX FONDEN'S PROCESSING OF PERSONAL DATA – ACTIVE SENIOR CITIZENS

Collection of personal data in connection with application

In connection with the completion and submission of the application to VELUX FONDEN, where you are a co-applicant, the information concerning you, provided to VELUX FONDEN by a principal applicant, will be registered and processed by VELUX FONDEN.

The data VELUX FONDEN processes concern your name and age.

The purpose of the data processing

The purpose of VELUX FONDEN's processing of your personal data is for THE VELUX FOUNDATIONS to be able to verify that an application to VELUX FONDEN for a grant has been submitted by a senior citizen who is engaged in an active initiative benefiting society at large.

Your personal data will be processed on the basis of VELUX FONDEN's legitimate interest in processing data on applications received and granted projects; see Article 6 (1), lit f EU General Data Protection Regulation (GDPR) (balancing of interests rule).

You are free to decide if you wish to allow THE VELUX FOUNDATIONS to process your data as a co-applicant.

The data you provide to VELUX FONDEN will be erased or anonymised as and when the purpose for which they were collected has been fulfilled. The data will be deleted no later than 6 months after a decision has been made on your application. This applies regardless of whether THE VELUX FOUNDATIONS award you a grant on the basis of the application.

Disclosure of personal data

VELUX FONDEN will not disclose your personal data to a third party.

As part of the processing of your personal data, your data will be stored on servers located in countries outside the EU/EEA and will be accessed from countries outside the EU/EEA for purposes of server maintenance. VELUX FONDEN warrants that your data will only be transferred to third countries, which, pursuant to a decision by the European Commission, ensure an adequate level of protection or on the basis of standard provisions for data protection adopted by the European Commission, which are binding upon the recipient of personal data in the third country.

Your rights

You have the right to access the data processed concerning you, the right to object to the processing of the data and the right to request rectification or erasure of your personal data. You have the right at any time to request restriction of the processing of your personal data and to object to VELUX FONDEN's processing of your personal data.
